WHEREAS the South Haven Charter Township Board, pursuant to MCLA 41.181 may adopt an ordinance regulating public health, safety, traffic, the use of streets, highways and alleys; and,

WHEREAS, South Haven Charter Township has contracted for the providing of police services with full power to enforce Township Ordinances and state laws;

NOW THEREFORE, SOUTH HAVEN CHARTER TOWNSHIP hereby ordains:

Sec. 1. Code and Amendment and Revisions adopted:

The Michigan Vehicle Code, 1949 PA 300, MCL 257.1 to 257.923, and all future amendments and revisions to the Michigan Vehicle Code when they are effective in this state are incorporated and adopted by reference.

Sec. 2. References in Code:

References in the Michigan Vehicle Code to "local authorities" shall mean SOUTH HAVEN CHARTER TOWNSHIP.

Sec. 3. Notice to be Published:

The Township clerk shall publish this ordinance in the manner required by law and shall publish, at the same time, a notice stating the purpose of the Michigan Vehicle Code and the fact that a complete copy of the code is available to the public at the office of the clerk for inspection.

Sec. 4. Penalties

The penalties provided by the Michigan Vehicle Code are adopted by reference, provided, however, that the SOUTH HAVEN CHARTER TOWNSHIP may not enforce any provision of the Michigan Vehicle Code for which the maximum period of imprisonment is greater than 93 days.

Effective Date: This ordinance shall become immediately effective upon its adoption and notice of publication as required by law.
